A BILL

To require the suspension of the use, sale, development, production, testing, and export of depleted uranium munitions pending the outcome of certain studies of the health effects of such munitions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) Short Title.—This Act may be cited as the
- 5 "Depleted Uranium Munitions Suspension and Study Act
- 6 of 2006".

3 SEC. 2. FINDINGS.

- 4 Congress makes the following findings:
- (1) The highest regard should be given to the
 health and safety of the Nation's military personnel.
- 7 (2) Among the characteristics of depleted ura-
- 8 nium munitions are that (A) they are pyrophoric, re-
- 9 sulting in the munition burning upon impact with a
- target, and (B) the impact of a depleted uranium
- munition on a target creates aerosol particles, which
- can be inhaled.
- 13 (3) Depleted uranium munitions were used by
- the United States in 1991 during the Persian Gulf
- War in Southwest Asia and during the conflicts in
- the former Federal Republic of Yugoslavia (Bosnia,
- 17 Kosovo, Serbia, and Montenegro) during the 1990s,
- with approximately 300 metric tons of depleted ura-
- 19 nium being used during the Gulf War, three metric
- tons being used in Bosnia, and over nine metric tons
- being used in Kosovo, Serbia, and Montenegro.

- 1 (4) The United States has provided or sold de-2 pleted uranium and depleted uranium munitions to 3 allied nations, and the United Kingdom used de-4 pleted uranium munitions during the Persian Gulf 5 War.
 - (5) Depleted uranium munitions have been used at numerous United States military installations, proving grounds, and testing facilities.
 - (6) The Yugoslav and Iraqi Governments have claimed that depleted uranium is affecting the health of their people, although such claims have yet to be independently verified.
 - (7) No definitive cause has been established for the various illnesses (commonly referred to as "Gulf War Syndrome") that currently affect approximately 130,000 United States servicemembers and veterans who served in Southwest Asia during the Persian Gulf War.
 - (8) The British Royal Navy, Canadian Navy, and United States Navy have all announced that they would phase out use of depleted uranium munitions.
 - (9) It has been reported that depleted uranium munitions use has proliferated to more than 20 nations.

- (10) Crash investigators of the Federal Aviation Administration are instructed, in FAA Advisory Circular 20–123, dated December 20, 1984, to "handle with caution" any depleted uranium that they encounter in crash investigations, and are instructed that "the main hazard associated with depleted ura-nium is the harmful effect the material could have if it enters the body," and that "[i]f particles are in-haled or digested, they can be chemically toxic and cause a significant and long-lasting irradiation of in-ternal tissues,".
 - (11) The 1949 Geneva Convention specifically outlines the precautions warring nations must take to avoid harming civilian populations, and it would be a violation of the 1977 Protocol to that Convention to cause superfluous injury or unnecessary suffering to civilians, as depleted uranium has the potential to cause.
 - (12) The Department of Defense has acknowledged that stocks of depleted uranium munitions have been contaminated with transuranic elements, including plutonium.
 - (13) Plutonium is an extremely toxic, carcinogenic, and radioactive material with a half-life of 4.5 billion years.

1 SEC. 3. PURPOSES.

2	The purposes of this Act are the following:
3	(1) To eliminate health threats from depleted
4	uranium munitions to—
5	(A) United States military personnel and
6	United States civilian employees;
7	(B) military personnel and employees of
8	member nations of the North Atlantic Treaty
9	Organization; and
10	(C) civilian populations in regions where
11	such munitions were used (whether in conflict,
12	training, or development) or produced.
13	(2) To provide for studies of—
14	(A) the level and scope of contamination of
15	depleted uranium munitions by plutonium and
16	other transuranic elements;
17	(B) the health effects resulting from expo-
18	sure by inhalation, ingestion, or injection to de-
19	pleted uranium munitions; and
20	(C) environmental contamination caused
21	by depleted uranium at sites where depleted
22	uranium was used in conflict, development, test-
23	ing, or training and at sites where depleted ura-
24	nium and depleted uranium munitions were
25	produced.

1	(3) To require the Administrator of the Envi-
2	ronmental Protection Agency to issue regulations
3	and requirements, based upon Environmental Pro-
4	tection Agency studies, concerning the cleanup and
5	mitigation of depleted uranium contamination at
6	sites of depleted uranium munition use and produc-
7	tion in the United States.
8	SEC. 4. SUSPENSION OF USE OF DEPLETED URANIUM MU-
9	NITIONS.
10	(a) Suspension of Use.—Effective no later than 90
11	days after the date of the enactment of this Act, the Sec-
12	retary of Defense shall direct that all elements of the De-
13	partment of Defense suspend use of depleted uranium mu-
14	nitions.
15	(b) Duration.—(1) The suspension of use of de-
16	pleted uranium munitions required by subsection (a) shall
17	remain in effect until the Secretary of Health and Human
18	Services, based upon the results of the study under section
19	7(a), certifies to the committees specified in paragraph (2)
20	that use of depleted uranium munitions in future con-
21	flicts—
22	(A) will not pose a likely long-term or residual
23	threat to the health of United States or NATO mili-
24	tary personnel; and

1	(B) will not jeopardize the health of civilian
2	populations in the area of such use.
3	(2) The committees specified in this paragraph are
4	the following:

- 5 (A) The Committee on Armed Services and the 6 Committee on Government Reform of the House of
- 7 Representatives.
- 8 (B) The Committee on Armed Services and the 9 Committee on Homeland Security and Governmental
- 10 Affairs of the Senate.
- 11 (c) Future Use Limited to Stocks Free of
- 12 Transuranic Matter.—Upon a certification by the Sec-
- 13 retary of Health and Human Services described in sub-
- 14 section (b), the Secretary of Defense shall limit any subse-
- 15 quent use of depleted uranium munitions to stocks of such
- 16 munitions that the Secretary certifies to be free of pluto-
- 17 nium and other transuranic matter.
- 18 SEC. 5. SUSPENSION OF SALE AND EXPORT OF DEPLETED
- 19 URANIUM MUNITIONS.
- 20 (a) Suspension of Sale and Export.—Upon the
- 21 enactment of this Act, all elements of the Government
- 22 with responsibility for approving the foreign sale or export
- 23 of munitions shall suspend the approval of the sale and
- 24 export of munitions containing depleted uranium.

- 1 (b) DURATION.—The suspension required by sub-
- 2 section (a) of approval of the foreign sale and export of
- 3 depleted uranium munitions shall remain in effect until
- 4 the Secretary of Health and Human Services makes a cer-
- 5 tification described in section 4(b).
- 6 (c) Future Exports To Be Limited to Stocks
- 7 Free of Transuranic Matter.—Upon a certification
- 8 by the Secretary of Health and Human Services described
- 9 in section 4(b), any subsequent foreign sale or export of
- 10 depleted uranium munitions or preproduction depleted
- 11 uranium may be made only from stocks of such munitions
- 12 or preproduction depleted uranium that the Secretary of
- 13 Defense certifies to be free of plutonium and other trans-
- 14 uranic matter, excluding depleted uranium.
- 15 SEC. 6. COMPTROLLER GENERAL INVESTIGATION OF PLU-
- 16 TONIUM CONTAMINATION.
- 17 (a) Investigation.—The Comptroller General of the
- 18 United States shall conduct a full investigation into the
- 19 contamination of stocks of depleted uranium munitions
- 20 with transuranic elements, including plutonium, neptu-
- 21 nium, americium, and other forms of uranium. The inves-
- 22 tigation shall include—
- 23 (1) determination of when such contamination
- 24 occurred;

- 1 (2) identification of the manufacturing or refin-2 ing facilities at which such contamination occurred;
 - (3) identification of the quantity, by volume and percentage, of the material by which such contamination occurred;
 - (4) identification of when such contamination was first realized by Department of Defense personnel and when such contamination was brought to the attention of senior Department of Defense management;
 - (5) identification of persons responsible for monitoring the quality of such production;
 - (6) identification of the time when notification of such contamination was made to member nations of the North Atlantic Treaty Organization; and
 - (7) determination of whether any law or treaty was broken by any such contamination or by any failure to provide timely notice of such contamination to any affected party.
- 20 (b) REPORT.—Upon completion of the investigation 21 under subsection (a), the Comptroller General shall sub-22 mit to the committeed specified in section 4(b)(2) a report 23 on the investigation.

1	SEC. 7. STUDY OF HEALTH EFFECTS OF DEPLETED URA-
2	NIUM.
3	(a) Study.—The Director of the Agency for Toxic
4	Substances and Disease Registry and the Director of the
5	Center for Disease Control and Prevention shall jointly
6	conduct a comprehensive study of the health effects of ex-
7	posure to depleted uranium munitions on uranium-exposed
8	veterans and on their children who were born after their
9	respective exposures to uranium.
10	(b) Uranium-Exposed Veterans.—For purposes
11	of this section, the term "uranium-exposed veteran"
12	means a member or former member of the Armed Forces
13	who while on active duty handled, came in contact with,
14	or had the likelihood of contact with depleted uranium mu-
15	nitions, including members and former members who while
16	on active duty—
17	(1) were exposed to smoke from fires resulting
18	from the burning of vehicles uploaded with depleted
19	uranium munitions or fires at depots at which de-
20	pleted uranium was stored;
21	(2) worked within environments containing de-
22	pleted uranium dust or residues from depleted ura-
23	nium fires;
24	(3) were within a structure or vehicle while it
25	was struck by a depleted uranium munition;

- 1 (4) climbed on or entered equipment or struc-2 tures struck by depleted uranium; or
- 3 (5) were medical personnel who provided near-
- 4 term treatment to members of the Armed Forces de-
- 5 scribed in paragraph (1), (2), (3), or (4).
- 6 (c) Public Health Assessment.—The Director of
- 7 the Agency for Toxic Substances and Disease Registry
- 8 shall conduct a public health assessment of persons who
- 9 are thought to have an epidemiological link to any United
- 10 States military installation or facility at which depleted
- 11 uranium munitions have been or currently are used or any
- 12 production facility at which depleted uranium or depleted
- 13 uranium munitions are currently, or have been, produced.
- 14 (d) Report.—The Directors shall submit to Con-
- 15 gress a report on the results of the study under subsection
- 16 (a) and the assessment under subsection (c). The report
- 17 shall be submitted not later than two years after the date
- 18 of the enactment of this Act and shall include the findings
- 19 of the Directors on the matters covered by the report. The
- 20 Directors shall include in the report a list of diseases or
- 21 conditions that are found to exist within the populations
- 22 specified in subsection (a) and their rate of occurrence
- 23 compared to the general population.

1	SEC. 8. EPA STUDIES OF ENVIRONMENTAL CONTAMINA-
2	TION BY DEPLETED URANIUM.
3	(a) List of Locations in United States.—Not
4	later than 180 days after the date of the enactment of
5	this Act, the Secretary of Defense shall provide to the Ad-
6	ministrator of the Environmental Protection Agency a list
7	of all sites in the United States where depleted uranium
8	munitions have been used or produced and a site-specific
9	map of each such site.
10	(b) EPA Studies.—After receipt of the list and
11	maps under subsection (a), the Administrator shall, for
12	each site specified on the list, conduct a comprehensive
13	environmental study of the possible contamination of the
14	soil, air, water, and vegetation by depleted uranium at
15	that site.
16	(c) Report.—Not later than two years after the date
17	of the enactment of this Act, the Administrator of the En-
18	vironmental Protection Agency shall submit to the Sec-
19	retary of Defense and the Committee on Armed Services
20	and the Committee on Government Reform of the House
21	of Representatives and the Committee on Armed Services
22	and the Committee on Homeland Security and Govern-
23	mental Affairs of the Senate a report—
24	(1) describing the extent of contamination by
25	depleted uranium at each site studied by the Admin-

istrator pursuant to subsection (b);

1	(2) providing site-specific recommendations for
2	the mitigation and cleanup of each such site; and
3	(3) providing general recommendations regard-
4	ing the cleanup of sites where depleted uranium has
5	been used on foreign lands.
6	SEC. 9. ENVIRONMENTAL MITIGATION AND CLEANUP RE-
7	QUIREMENTS.
8	(a) Department of Defense Cleanup Plan.—
9	Not later than one year after receiving the report under
10	section 8(c), the Secretary of Defense shall develop a plan
11	for mitigation and cleanup at each site and a prioritized
12	list for such cleanups. The Secretary shall submit a copy
13	of the plan to the Committee on Armed Services and the
14	Committee on Government Reform of the House of Rep-
15	resentatives and the Committee on Armed Services and
16	the Committee on Homeland Security and Governmental
17	Affairs of the Senate.
18	(b) Report.—The Secretary shall submit a report to
19	those committees and the Administrator of the Environ-
20	mental Protection Agency each year before commencement
21	of the mitigations and cleanups until those projects are
22	complete.

- 23 (c) CLEANUP.—After filing of such plans, the Sec-24 retary shall commence, or contract for, the mitigation and
- 25 cleanup of each site for which the Administrator of the

- 1 Environmental Protection Agency has recommended such
- 2 mitigation and cleanup and in the manner and scope that
- 3 the Administrator's report specifies.
- 4 (d) Applicability of NEPA.—Notwithstanding
- 5 any other provision of law, the cleanup and mitigation re-
- 6 quired by subsection (c) shall be carried out in a manner
- 7 consistent with the provisions of the National Environ-
- 8 mental Policy Act of 1969, without regard to any exemp-
- 9 tion to any of the provisions of that Act for the Depart-
- 10 ment of Defense or any element thereof.
